From 7 December 2025, you will also have to pay a reminder fee. You will then pay €9.00 reminder costs.

You can request a correction up to **24 April 2025**.

## This is where you drove

You drove on the A24. This is the road between the A15 near Rozenburg and the A20 near Vlaardingen. You have to pay toll if you drive on this road.



## If you have already paid

You have already paid toll and are still receiving this letter? That can happen in one of these 3 situations:

1. You paid toll too early (more than 7 days before your toll ride).
2. You paid toll too late (more than 3 days after your toll ride).
3. You did not pay enough toll (because your vehicle is heavier than 3,500 kg).

You will have to pay the amount listed on the front of this letter. We will give you back the toll you have already paid within 14 days.

### e-TOL

e-TOL stands for paying tolls without stopping on the A24 motorway. Multiple government organisations are collaborating on implementing this system. More information is available at [e-tol.nl/aboutus](http://e-tol.nl/aboutus).

### Central Judicial Collection Agency (CJIB)

If you do not pay on time, you will be fined by the CJIB. If you do not pay the fine, CJIB may take measures to make you pay anyway. The CJIB may then involve a bailiff, for example. You will be required to pay the costs of any measures taken in addition to the fine.
